Samyang KCI Safety and Health Management Policy



1. Purpose

Under its business philosophy "Respect for Human," Samyang KCI (hereinafter the "Company") embraces "Safety and Health" as its core business value and has developed the Samyang KCI Safety and Health Policy. This is to encourage all stakeholders including employees and partner companies to adhere to the Safety and Health Management Policy so that the Company can create heathy and safe work environment.

Safety and Health Management Guidelines

- All employees of Samyang KCI and its suppliers voluntarily participate in safety and health activities.
- All employees of Samyang KCI and its suppliers faithfully comply with laws and regulations related to safety and health.
- All employees of Samyang KCI and its suppliers shall do their best to prevent any accidents by actively identifying and improving hazards and risk factors at business sites.
- The CEO establishes a safety and health management system and continuously monitors, maintains, and develops it to ensure efficient operation.

2. Scope

All Samyang KCI employees across the Company's business sites and stakeholders including suppliers and business partners shall be covered by this Safety and Health Management Policy.

3. Owners

Samyang KCI appoints the responsible management personnel for health and safety affairs as CEO, and establishes Environment, Safety & Health Part, a dedicated organization for safety and health oversight to carry out business site safety and health-related measures including instruction, counsel and implementation monitoring, etc.

In addition, Samyang KCI establishes Occupational Safety and Health Committee and Safety and Health Council of which supervisors, safety officers, health officers and employees at each business site consist under the leadership of safety and health manager and Chief Safety and Health Officer, to identify safety and health related hazards risks and implement relevant improvement activities not only for the sake of its employees but also its partner companies and their employees.

Every year, Samyang KCI develops and reports its annual safety and health plan to the Board of Directors (BoD) and obtain approval for the plan from the BoD. The Company faithfully delivers its safety and health plan, and analyzes and evaluates its safety and health management performance according to the plan and changes in the safety and health control for its business sites.

4. Safety and Health Management

1) Safety and Health Goal Setting and Review

To prevent safety and health hazards or risks for its employees, Samyang KCI sets and reports realistic and concrete safety and health goals considering the nature of each business site, and monitors and reviews each site's actual performance progress against goals at least once every six months.

2) Employee-Participating Hazards Risks Identification and Improvement

To create a safe business site, Samyang KCI holds a procedure to identify and improve hazards risks in which employees who understand potential safety and health risks the most. The result of the procedure is communicated with and uploaded to Occupational Safety and Health Committee to ensure its employees' compliance. Also, Samyang KCI regulates report(s) to its CEO regarding whether the identification and improvement is made in accordance to the procedure at least once every six months.

3) Employee Voice and Improvement

To prevent occupational accidents, Samyang KCI establishes Occupational Safety and Health Committee and Safety and Health Council in which the shop floor operators who hold the best knowledge on the work site participate, so that all employees can freely express their safety and health related opinions regarding occupational hazards risks. When such opinion is found to be relevant to prevent occupational accidents, the Company develops corrective plan whose implementation is monitored by the CEO at least once every six months, followed by necessary measures.

4) Trainings and Drills

Samyang KCI provides safety and health drills to prepare for actual emergencies and systemic trainings to improve employees' safety awareness, which all lead to the prevention of potential risks.

5) Safety and Health Certificates

For site operation based on autonomous safety and health management system, Samyang KCI has obtained ISO 45001, an international standard for occupational health and safety management. Based on such standard and system, Samyang KCI sets safety and health strategy and goals and carry out continuous improvement activities to maintain a systemic safety and health management system.
