Samyang KCI Sustainable Supply Chain Management Policy



1. Purpose

Upholding its ethics management principle "With fair transaction culture set in place, Samyang KCI pursues mutual growth with its partners," Samyang KCI aims to build a long-term partnership with partner companies, encourages its partners to increase their awareness of ESG management and to secure necessary management skills for a sustainable mutual growth. In addition, Samyang KCI seeks to source sustainable raw materials and protect forests as part of its procurement policies to fulfill its social responsibility across the entire supply chain.

2. Directive for Supply Chain ESG Management

Samyang KCI adheres to the following principles for sustainable supply chain management.

(1) Compliance to Supplier Code of Conduct (CoC)

Samyang KCI recognizes its environmental, social and financial responsibility arising from its procurement activities, and its transaction should be with suppliers in compliance with Samyang KCI's Supplier CoC in principle.

- 1) Supplier Code of Conduct is made up with 5 areas human rights management, safety & health management, environment management, ethics management, and management system and is applied to all partners who supply products and services to Samyang KCI.
- 2) Samyang KCI confirms suppliers' consent to Supplier CoC compliance when registering new suppliers along with existing suppliers.

(2) Supplier ESG Risk Management Process

Samyang KCI strives to prevent and mitigate suppliers' ESG risks arising from procurement activities. In accordance with the Supplier ESG Risk Management Process, the Company monitors such risks and lends support for improvement.

- 1) Samyang KCI requests compliance with Supplier Code of Conduct (CoC) for all suppliers while conducting ESG Risk Document Review over its key suppliers.
- 2) Questionnaires in Samyang KCI ESG Risk document Review are based on Supplier CoC, and Samyang KCI conducts the Document Review once a year.
- 3) Samyang KCI performs site audits led by external experts against suppliers with high ESG risk level identified from the Document Review.
- 4) Samyang KCI requests improvements on identified ESG risks and monitors the progress. In addition, Samyang KCI provides vigorous support for suppliers to make improvements.

3. Directive for Sustainable Raw Material Sourcing

Samyang KCI sets Directive for Sustainable Raw Material Sourcing centered on key raw materials, and adheres to the following principles.

(1) Fats and Oils (Palm Oil)

- 1) Samyang KCI understands the fact that sustainable approach to produce palm oil from the land and supply the oil may impact the environment, climate change and biodiversity.
- 2) Samyang KCI is a member RSPO (Roundtable on Sustainable Palm Oil) to resolve environmental devastation of palm oil production regions and human rights issues for a sustainable access to pal oil sourcing, and purchases palm oil produced in accordance with legitimate procedure. Samyang KCI also obtained RSPO Supply Chain certificate to purchase certified palm oil (Mass Balance grade).

(2) Hazardous Chemical Substances

- In accordance with the international standard and customer's product hazardous substances
 control policy, Samyang KCI controls to prevent using restricted substances during the
 production process. Samyang KCI establishes and runs integrated control system to ensure the
 part and packaging it purchases does not contain restricted substances.
- 2) Samyang KCI adheres to the Restriction of Hazardous Substances in Electrical and Electronic Equipment (EU RoHS Directive) and EU REACH for its product procurement and production R&D. To this end, Samyang KCI prohibits the use of cadmium (Cd), lead (Pb), mercury (Hg), hexavalent chromium (Cr6+), brominated flame retardant (PBB, PBDE) and SVHC (Substances of Very High Concern).

(3) Conflict Minerals

- Samyang KCI recognizes severe labor rights issues arising from the production of conflicted minerals (tin, tantalum, tungsten and gold) that come from 10 African countries with conflicts (Democratic Republic of Congo, Sudan, Rwanda, Burundi, Uganda, Congo Republic, Zambia, Angola, Tanzania, Central Africa Republic.)
- 2) Samyang KCI goes beyond not using and purchasing those conflict minerals, providing supports to its suppliers to recognize the problems of conflict minerals, monitor their control status, and strengthen their control measures.

4. Directive for Forest Protection

Samyang KCI fulls compliance with the following Directives for Forest Protection and the laws in the country and regions where the company's business sites are located when sourcing raw materials, including palm oil. If deforestation or conversion occurs in the company's operations, Samyang KCI promises its efforts to support restoration.

(1) No Deforestation

- Samyang KCI recognizes the importance and responsibility of the EUDR (EU Regulation on Deforestation-free Products) and strives to comply with the regulation. Samyang KCI collaborates with various suppliers to contribute to forest conservation and to establish a deforestation-free supply chain.
- 2) Samyang KCI should purchase deforestation- and forest clearing-free products, and such zero deforestation efforts include no development of areas classified as HCV (High Conservation Value) and HCS (High Carbon Stock).
- 3) Samyang KCI will adhere to RSPO (Roundtable on Sustainable Palm Oil) or equivalent certificate standard and all applicable local laws. Also, Samyang KCI promises its efforts to deliver Principle of Zero Deforestation and to preserve biodiversity including the forest by identifying, protecting and preserving regions with high conservation value.

(2) Peatland

- Peatlands are collectively a major carbon store, a key to preserving biodiversity. Samyang KCI
 prohibits new development of peatlands regardless of depth and strives to minimize
 destruction of and damage to peatlands.
- 2) Samyang KCI takes appropriate environmental protection measures when sourcing raw materials from peatlands, and partners with experts and navigate ways to preserve peatlands such as finding eco-friendly alternatives or peatland restoration.

(3) No Conversion

- 1) Conversion of forests to agricultural, industrial, or other non-forest uses can lead to severe global issues such as biodiversity loss, global warming, reduced climate change resilience, accelerated climate change, water shortage, and decreased food production.
- 2) Samyang KCI promises to produce products and source raw materials without conversion of natural habitats, forests, wetlands, or other forested areas in the company's operations.

5. Directive for Ethical Procurement

Samyang KCI adheres to the following principles to build a sustainable supply chain ecosystem via ethical and fair procurement.

(1) Prohibition of Gifts and Gratuities from Stakeholders

Samyang KCI strictly prohibits its procurement personnels accepting gifts and gratuities from stakeholders. Such gifts and/or gratuities should be cordially declined or returned when received inevitably.

(2) Prohibition of Unfair Shareholding in Stakeholders

Samyang KCI prohibits its procurement personnels obtaining unlisted shares of suppliers with interest or using unfair information to obtain listed shares of suppliers.

(3) Fairness and Transparency in Supplier Selection

Samyang KCI selects most competitive suppliers based on the "fairness and transparency" principle. When supply term limits or adjustments are necessary, Samyang KCI provides clear and reasonable reasons and proceed the process in a transparent manner.

(4) Prohibition of Illegal/Unfair Use of Company Asset

In/tangible assets, classified information, etc. in possession of KIC are important asset of the Company, and their use is limited to business and approved purposes. All Samyang KCI employees are responsible for preparation efforts against asset loss, misuse and theft. In particular, company expenses are company funds, which should be used for due purpose following appropriate procedures.

(5) Prohibition of Document/Calculation and False Report

Samyang KCI strictly prohibits falsely producing any documents or manipulating/counterfeiting calculations both knowingly and inadvertently.

(6) Prohibition of Unfair Information Collection

Samyang KCI collects all business-related information including competitor information, intellectual properties, supplier's classified information in a fair way that does not legally/ethically violate regulations. Samyang KCI prohibits unfair collection of information such as collecting leaked data without the consent of owner.

6. Addendum

- (1) This Sustainable Supply Chain Management Policy was established and took into effect as of May 3, 2024.
- (2) This Sustainable Supply Chain Management Policy was revised and took into effect as of November 5, 2024.
- (3) This Sustainable Supply Chain Management Policy was revised and took into effect as of April 1, 2025.
